Factors that can complicate transactional tax management



Multijurisdictional operations require navigating a variety of tax systems, laws, and compliance requirements simultaneously. If that extends to international sales, you'll also have to comply with customs duties and trade regulations in addition to indirect taxes, which vary by country. Avalara commissioned Forrester Consulting to conduct a **Total Economic Impact™ (TEI) study** on the return on investment (ROI) companies might expect by automating tax compliance with Avalara. Forrester interviewed Avalara customers about the ROI they realized from Avalara's solutions and constructed a composite global company and aggregate financial analysis from their responses.

Prior to automating tax compliance with Avalara, interviewees said they experienced difficulty collecting and remitting tax in all jurisdictions where they have nexus due to frequent tax law changes. Study participants also said their businesses faced challenges managing exempt sales and higher audit risk due to incorrect or missing forms when filing returns. After implementing Avalara, TEI study participants said they were able to more accurately calculate taxes, reduce time and errors filing tax returns, efficiently manage exemption certificates, and prepare for audits, which effectively lowered their organizations' potential liabilities for noncompliance.

Growth from acquisitions led Pacon, a leading supplier of educational and art products, to experience more complicated tax requirements. Inovonics

Wireless technology manufacturer Inovonics faced complex compliance obligations due to their multistate operations. Like many companies that deal with distributors, Inovonics underestimated where it had nexus and was obligated to register, collect, remit tax, and file returns. A nexus study found the company had tax obligations in 14 more states beyond the six where they were registered.

Furthermore, the company's financial system wasn't up to the task of handling tax compliance effectively. "You really have to stay on top of all your rates and you have to do all the filing yourself," says Andrea Riviezzo, Inovonics controller.

Exemption certificate management was also an issue. "If you have a drop shipment and you put the certificate ID on a customer card, it flows through to wherever they are drop shipping," Riviezzo explains. "So, if they're exempt in California but not in New Jersey, you've created issues there as well."

Inovonics took the advice of a trusted advisor and chose Avalara's comprehensive tax automation compliance suite to automate tax collection on all its sales, file returns in 20 states, and manage exemption certificates.
